With reference to proposal submitted by FRI Deemed University, FRI, Dehra Dun vide letter No. 2386/2-1/2009-FRIU, dated 29.07.2011 and on the recommendation of the ICFRE Accreditation Committee, the Director General, ICFRE is pleased to sanction **Rs. 18.75 Lakhs** (Rupees Eighteen lakh Seventy five thousand only) FRI Deemed University, FRI, Dehra Dun as grant in aid to give impetus to forestry education in the University. The grant is approved for the following specific items:



The expenditure is chargeable to the budget sub-head **Plan (G.C.) Plot 13 Grant to Universities** against the budgetary allocation for the year **2011-12**. The grant shall be strictly utilized for the purpose as specified above, during the current financial year. Utilization of grant-in-aid will be subject to verification/monitoring by this Council and the general conditions laid down as under:-

1. The University should make provision for submission of audited statements of expenditure as the same is required as per General Financial Rules.
2. The assets created by the utilization of grant-in-aid should be dully acknowledged by displaying Name and Logo of ICFRE at prominent places. The year of formation and cost of the project should be written on such assets.
3. The University shall submit utilization certificate for the grant as per Annexure II of expenditure statement as per Annexure III of guidelines for Grant-in-Aid already available with universities. Photo-documentation of the buildings, equipments, Teaching/Research facilities, museums centres and important events such as seminar, symposia, students study tours, sports and games, field demonstration and extension, camps etc. should be sent to ICFRE along with Utilization Certificate for each financial year.
4. All codal formalities should be observed and expenditure sanction of competent authority obtained before carrying out works. The university shall be responsible for proper utilization of the grant viz a viz quality and quantity specification.
5. The expenditure account shall be audited by an appropriate authority and the audit certificate be submitted to this Council within two months of utilization certificate.
6. The guidelines for grant- in- aid under which the proposal has been submitted by the university should be strictly adhered to. The guidelines are available for reference at our website [www.icfre.org](http://www.icfre.org)
