



Aligarh

It has been decided that Muslim University Jawaharlal Nehru Medical College Hospital, Aligarh, may be treated as recognized College for treatment of Central Government servants and members of their families under Rule 2 (d) of the CS (MA) Rules, subject to the condition that treatment is taken on the advice of the Authorized Medical Attendant and on his issuing a certificate that the requisite facilities for treatment are not available in any Government Hospital at Aligarh. Reimbursement will be made in accordance with the schedule of charges of the hospital.

Dehradun

It has been decided that the Himalayan Institute Hospital Trust Jolly Grant, Dehradun (Uttaranchal) may be treated as a recognized hospital under Rule 2 (d) of the CS (MA) Rules, 1944, for the treatment of Central Government employees and the members of their family for the purposes of General and Specialized treatment and diagnostic facilities except Invasive Cardiology, Cardiothoracic Surgery, Radio Therapy and Transplantation.

2. The schedule of charges for the treatment of Central Government employees and the members of their family under the CS (MA) Rules, 1944, will be regulated as per the schedule of approved charges applicable for CGHS Meerut. For services, where the rates of Himalayan Institute Hospital are lower than the CGHS rates, the lowest rates are to be charged.

3. The authorities of the Himalayan Institute Trust Hospital, Jolly Grant Dehradun will have to enter into an agreement with the Government of India to the effect that the Hospital will charge from the Central Government employees and their dependent family members at the rates fixed by the Government and 45% of the charges payable to the Government employees for the treatment of 3 months from the date of issue of the above-mentioned O.M., failing which the Hospital will be derecognized. Subject to above, the Hospital can start treating Central Government employees covered under CS (MA) Rules, 1944.
