

# INSTITUTE OF FOREST GENETICS AND TREE BREEDING –COIMBATORE

## 1. Particulars of its organisation, functions and duties

The Institute of Forest Genetics and Tree Breeding (IFGTB) was formed in April 1988. It was formed by up-gradation of the Forest Research Centre (FRC), Coimbatore under the Forest Research Institute and Colleges (FRI &C), existing since late 1950s. Other organizations and schemes viz., Forest Soil cum Vegetation Survey (FSVS), Coimbatore, Disease and Insect Survey (DIS), Coimbatore, Indo-Danish Project on Seed Procurement and Tree Improvement (IDPSPTI), Hyderabad, Tropical Pines Research Centre (TPRC), Kodaikanal, Eucalyptus Research Centre (ERC), Ooty and Environmental Research Station (ERS), Ooty were merged with the FRC to form the Institute.

### **Jurisdiction**

IFGTB is located in the Forest Campus in Coimbatore city, spread over about 150 acres. The Institute conducts national level research on the subjects of genetics and tree breeding of important forest species. In addition, it also attends to the regional forestry research problems of Tamil Nadu, Kerala, Puducherry, Andaman & Nicobar Islands and Lakshadweep.

### **Mandate**

To identify and evolve varieties of species used in afforestation and social forestry that will contribute to the national goal of achieving a growth of 3 to 4 cubic meters of biomass per hectare per year within the ecological considerations applicable to the area.

### **Mission**

**National:** To assess, characterize and utilize the genetic diversity of forest tree species and carry out tree improvement of major plantation species through breeding, biotechnological interventions and appropriate silvicultural packages with the objective of increasing the productivity of our forests and plantations to meet the requirements of the forest fringe communities and forest based industries besides restoring the ecology of degraded areas to expand the forest and tree cover and improving the environmental quality.

**Regional:** To attend to the forestry research requirements of the states of Tamil Nadu and Kerala and the Union Territories of Puducherry, Andaman & Nicobar Islands and Lakshadweep.

### **Core Competence**

To evolve trait specific trees with increased biomass production through conventional breeding strategies, biotechnological interventions and precision silvicultural practices.

### **Long-term goals of the Institute**

1. Increasing productivity in farmlands / plantations / homesteads by making available quality planting stock through quality seeds, scientific breeding programmes and biotechnological interventions.
2. Forest Genetic Resources Networking for conservation, management and sustainable utilization of commercial species to move towards the establishment of National Bureau of Forest Genetic Resources.
3. Promoting Consortia Based Research with a view to meeting the demands of wood based industries involving tree growers' co-operatives.
4. Resilience forestry to meet the challenges of climate change

5. Strengthen forests and plantation health, productivity enhancement, precision silviculture techniques through species specific approaches.
6. Restoration of fragile and degraded ecosystems
7. Forestry Extension and education programmes for stake holders

## **Organisation**

## **II. Powers and Duties of its Officers and Employees.**

1. To consider and provide advice on regional requirements for forest research over the whole spectrum of activities affecting forests & tree in land management.
2. To recommend annual research programs and level of budget allocation to the relevant Institute.
3. To review the progress and results from all research projects.
4. To revise research programme and new research proposals at the institute every year.

By representation of above including NGO's in formulation of plans, the representation of public was also ensured and the requirement of present day in forestry research is being assessed through the meetings of this group. As per recommendations of RAG, the projects are being formulated. There is another apex body of ICFRE known as "Research Policy Committee" (RPC). The main role of this committee is to review the

research projects cleared by RAG of its constituent Institute and to recommend the projects with prioritization for implementation in various Institutes.
