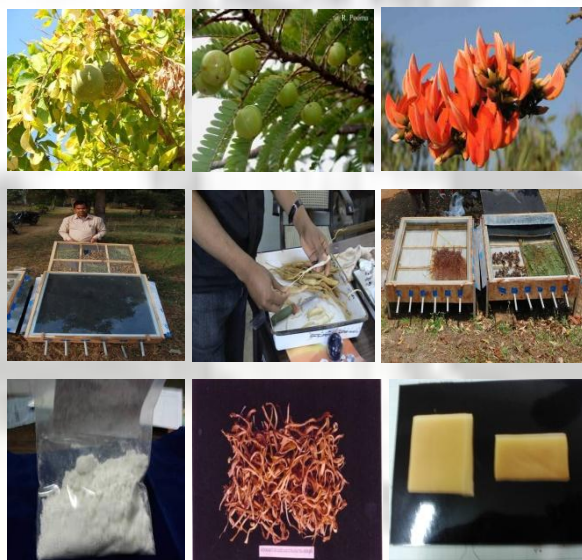

ABOUT THE INSTITUTE

Tropical Forest Research Institute (TFRI), Jabalpur is one of the premier Institute under the Indian Council of Forestry Research and Education, Dehradun (an autonomous body under Ministry of Environment, Forest and Climate Change, Govt. of India). It was established as a regional centre of Forest Research Institute, Dehradun in 1973 and become a full fledged Institute in April 1988 with a mandate to conduct research on Non wood forest products, Agroforestry, Forest protection, Biofertilizers and biopesticides, Rehabilitation of degraded lands and climate change, seed improvement and planting stock improvement etc. The institute is well equipped with modern analytical instruments and implements its mandate of research programme through competent scientists, forest officers and trained technical personnel placed in nine research divisions and one satellite centre 'Centre for Forestry Research and Human Resource Development' at Chhindwara, Madhya Pradesh. TFRI caters to the overall research needs of forests of four central Indian states, viz. Madhya Pradesh, Chhattisgarh, Maharashtra and Odisha in particular, and specific issues of forests and forestry sector confronting India, in general.

ABOUT TRAINING PROGRAMME

India is one of richest country in the world as regards to resources of medicinal plants. There has been a global interest in medicinal and aromatic (MAPs) based raw materials for production of herbal drugs, pharmaceuticals, essential oils, dietary supplements, nutraceuticals, colours, dyes, perfumery & cosmetic products and aroma compounds.

Processing and value addition technology of medicinal and aromatic plants includes several steps from cleaning to value added products. Appropriate processing technique is essential for getting maximum quality and quantity from the plants produce. Due to the lack of awareness, the medicinal and aromatic plant growers/collectors are unable to fetch good prices of their produce.

The purpose of this training course is to enhance the skills and abilities in processing and value addition techniques of medicinal and aromatic plants. This programme consists of lectures and practical demonstration to the participants.

TRAINING COURSE CONTENT

Training programme will include the following:

- **Introduction of economically valuable medicinal and aromatic plants of central India.**
- **Processing methods of medicinal and aromatic plants.**
- **Merits and demerits of different processing methods.**
- **Value addition of medicinal and aromatic plants.**
- **Demonstration of value addition and quality assessment techniques of MAPs.**

ELIGIBILITY CRITERIA

Progressive farmers, State Forest Departments/Research Institutes, Graduate and post graduate students, NGOs, Startup/Small entrepreneurs may participate in the training programme.

TRAINING FEE PER PARTICIPANT

Rs. 3000/- (Rupees three thousand only)

Training fee may be paid in cash or online or through Demand Draft favoring "Director, TFRI, Jabalpur" payable at Jabalpur from any nationalized bank. Fee once paid will not be refunded.
