## 2. DEFINITIONS

- a) **ADG (IT&FS), ICFRE** mentioned herein means the Assistant Director General (Information Technology & Forestry Statistics), ICFRE Dehradun representing ICFRE; and his official successors, nominees as may be designated by ICFRE from time to time.
- b) **EMD** means Earnest Money Deposit
- c) **PBG** means Performance Bank Guarantee
- d) **Firm** means a duly registered Firm or Company registered under Indian Laws as such, and bidding for this tender.

### 3. SCOPE OF WORK

- a) The Indian Council of Forestry Research and Education (ICFRE) invites sealed tenders in the prescribed format for Rate Contract of Inkjet / Laser Printer Cartridges and Miscellaneous items as per the **Schedule-I**.
- b) Validity of the Rate Contract shall be for the period of one year.
- c) On award of rate contract the supply orders will be placed by the Officers of Indian Council of Forestry Research & Education (ICFRE) and Forest Research Institute (FRI).
- d) The contracted firm will have to ensure delivery of item in full within 14 (fourteen) days from date of receipt of order.
- e) The minimum limit shall be one unit for each item.
- f) The contractor firm shall maintain stocks of contracted items and make firm deliveries against all supply orders.
- g) Rate contract will not guarantee that some minimum number of orders will be placed with the firm.

### 4. GENERAL TERMS AND CONDITIONS


- a) Bidders are advised to study the tender document carefully. Submission of bids shall be deemed to have been done after careful study and examination of the tender document with full understanding of its implications.
- b) Any clarifications from ICFRE or any change in requirement shall be posted on [www.icfre.gov.in](http://www.icfre.gov.in) and <https://eprocure.gov.in>. It shall be the sole responsibility of the bidder to check for any changes of aforementioned website before submitting the bids.
- c) ICFRE shall not be responsible for non-receipt / non-delivery of the bid documents due to any reason whatsoever.
- d) The bidder shall indicate the complete address of the Firm and work along with the name(s) of the contact person(s) and their telephone / Fax / Mobile Nos.(s) and other particulars as per **Form-I**.
- e) An EMD of Rs. 10,000/- (Rupees Ten Thousand only) in the form of Fixed Deposit Receipt or Bank Guarantee drawn on any nationalised bank in favour of D.D.O., ICFRE payable at Dehradun shall be deposited as a part of qualifying bid of the Tender. The EMD shall be returned to bidders upon finalization of the successful bidder and award of the contract. No interest shall be payable on the EMD by ICFRE. The EMD submitted by the bidder may be forfeited at any stage, if the bidder backs out of the bidding process after submitting the bids to ICFRE or fails to accept the work order issued to the firm.

- g) Acceptance of the bid shall be communicated to the successful bidder by a formal Letter of Intent (LoI).
- h) Conditional tenders are liable to be rejected.
- i) ICFRE reserves the right to accepted the tender in whole or in part.
- j) The ICFRE does not bind itself to accept the lowest quote or part thereof. ICFRE reserves the right to cancel any or all tenders received without assigning any reason thereof.
- k) All information submitted or supplied in the formats of this quotation document shall be presumed to be true to the best of knowledge of the bidder.
- l) **Within thirty days** of issue of Letter of Intent (LoI) the successful bidder shall
- Sign a contract with ICFRE for 'Rate Contract of Inkjet / Laser Printer Cartridges and Miscellaneous items', on a stamp paper of Rs. 100/- to be furnished by the firm.
  - Furnish a Performance Security issued by a Nationalised Bank in favour of DDO, ICFRE, Dehradun, having validity of three months beyond the date of expiry of the Contract, for an amount of Rs 10,000 (Ten Thousand only).

## 5. THE CONTRACT

- a) The tender document as a whole shall form the part of the Rate contract.
- b) If any part of the Rate Contract does not correspond or agree with any other part, or if any question arises as to the meaning of the terms of the contract or as to the performance of the work, Assistant Director General (IT & FS), ICFRE shall determine the matter and his decision shall be final and binding upon the parties hereto.
- c) The contract shall not be assigned or sublet in whole or in part by the firm without prior written consent of Assistant Director General (IT & FS), ICFRE. Any assignment or subletting of this contract by the firm or any interest therein, or of any money due or to become due by reason of the terms hereof, shall be null and void without prior written consent of Assistant Director General (IT&FS), ICFRE having been obtained.
- d) Initially the Rate Contract will be valid for a period of one year. Assistant Director General (IT & FS), ICFRE reserves the right to terminate contract by giving one-month notice without assigning any reason.
- e) ICFRE reserves the right to enter into parallel rate contract simultaneously with other parties.
- f) Rate contract will not guarantee any minimum number of orders will be placed with the firm.
- g) The price charges for the stores supplied by the contractor should not exceed

the lowest price at which the contractor sells stores of identical description to other persons during the period of the contract. Such act of the vendor shall lead to omission of the respective item from the Rate Contract.

- h) The contractor/supplier shall supply quality material/ product only against order placed by the purchaser or on his behalf.
- i) This contract shall not be deemed an asset of the firm in any form.
- j) In case the contractor is unable to supply the material within stipulated period due to some unavoidable reasons the same may be informed to the concerned officer stating time frame within which the supply will be made. The officer placing the supply order will notify his acceptance of delivery time offered by the contractor or negotiate until an agreement is reached. In all cases the delivery time, as accepted by the contractor and the officer placing the order, shall be deemed to be the essence of the contract and the delivery must be completed within time. In case the contractor still fails to supply the material, the officer placing the order will have the right to purchase the material from the market and the difference between the approved rates and the market price will have to be born by the contractor through recovery from the Performance Guarantee. Repetition of such instances by the contractor would result in termination of rate contract and forfeiture of performance guarantee.
- k) If the contractor violates any of these terms and conditions, the PBG shall be liable for forfeiture, wholly or partly, as decided by Assistant Director General (IT & FS), ICFRE and the contract may be cancelled.
- l) No legal proceedings to enforce any claim and no suite arising out of this contract shall be instituted except in a court of competent jurisdiction over Dehradun, Uttarakhand.
- m) No variation in or modification of the terms of the contract shall be made except by written amendment signed by both the parties i.e. the successful bidder and the ADG (IT&FS), ICFRE.
- n) The contract shall not be deemed an asset in any form by the firm.

#### 6. PAYMENT TERMS

- (i) Payment will be made within 30 (thirty) days from the date of receipt of the material in good condition, as per specifications given in the contract document and reproduced in the supply orders issued to the contractor firm from time to time by the concern official of ICFRE/FRI.
- (ii) Payment will be made on the basis of supplies executed by the successful bidder as per the supply orders issued to him from time to time, by respective Branch / Division / Directorate / placing such orders.
- (iii) The payment is subject to TDS as per Income Tax Rules / Laws. The ICFRE shall deduct such taxes, duties and any other statutory levies imposed by the Government on such charges as may arise from the

- implementation of the contract agreement.
- (iii) No claim on account of sales tax, service tax, VAT, work contract tax or any other taxes and duties presently in force for the material used for execution of the work awarded under the contract, will be entertained and all such taxes and duties shall be borne by the firm.
  - (iv) The violation of any of these terms and conditions mentioned in the Tender Document, the whole or part of Performance Bank Guarantee shall be liable for forfeiture, as decided by the Assistant Director General (IT&FS), ICFRE. Such decisions shall be the binding on the firm

## 7. ARBITRATION

Except where otherwise provided in the contract all questions and disputes whatsoever in any way arising out of or relating to the contract or otherwise concerning the work or the execution or failure to execute the same whether arising during the progress of the Maintenance Contract or after the completion or abandonment thereof shall be referred to the sole arbitration of the person appointed by the Director General, Indian Council of Forestry Research & Education, (DG, ICFRE) Dehradun on his behalf at the time of dispute. There shall be no objection to any such appointment that the arbitrator so appointed is an employee of ICFRE, or government servant or that he/she had to deal with the matters to which the contract relates or that in the course of his/her duties as an employee of ICFRE, or government servant, he had expressed views on all or any of the matters in dispute of differences. The arbitrator to whom the matter is originally referred being transferred or vacating his/her office or being unable to act for any reason, shall be replaced by another person as decided by DG, ICFRE, to act as arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage at which it was left by his/her predecessor. It is also a term of this contract that no person other than a person appointed by the Director General, ICFRE should act as arbitrator and if for any reason, that is not possible, the matter is not to be referred to arbitration at all in all cases where the amount of the claim in dispute is Rs. 50,000/- and above.

Subject as aforesaid, the provisions of the Arbitration and Conciliation Act 1996 or any statutory modifications or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceeding under this clause.

Services under the contract shall, notwithstanding the existence of any such dispute, question or controversy, continue during arbitration proceedings and no payment, due or payable by ICFRE or the firm shall be withheld on


account of such proceedings unless such payments are the direct subject of the arbitration. Reference to arbitration shall be a condition precedent to any other action at law.

#### 8. FORCE MAJEURE

- i) The performance of the obligations of either party under this Agreement is subject to Force Majeure.
- ii) If a Force Majeure situation arises, either party shall promptly notify to the other party in writing of such conditions and the cause thereof. Unless otherwise directed by ICFRE in writing, the vendor shall continue to perform its obligations under this agreement, as far as it is reasonably practical. Either party reserves the right to terminate this contract, without any additional liabilities to either party, if the Force Majeure period continues for more than 120 (One hundred and twenty days).

#### 9. PREPARATION AND SUBMISSION OF PROPOSAL

- i) Online bids are to be submitted under two Cover systems i.e. Cover 1 and Cover 2. All the pages of bid being submitted online must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading.
- ii) The proposal should not have any interlineations or overwriting except as necessary to correct errors made by the concerned themselves, in which cases such corrections must be initialed by the person or persons authorised to sign the proposal. No Financial Bid items pertaining to this tender shall be submitted as part of the qualifying documents and/or in the technical bid stage. In case of violation of this condition, the bid shall be rejected and no communication shall be entertained in this matter.
- iii) The completed proposal must be submitted mandatorily online at CPP portal <https://eprocure.gov.in/eprocure/app> after going through the terms and conditions given thereof. The offers submitted by Fax/email/offline shall not be considered and no correspondence shall be entertained in this matter.
- iv) The tender is not transferable. No assignment and sub contracting is permitted.
- v) Validity of offer shall be 120 days from the last date of submission of bids.
- vi) While submitting the bid, the bidder shall be deemed to have read, understood and accepted all the terms and conditions stated in this Tender Document.
- vii) Assistant Director General (IT&FS), ICFRE reserves the right to reject any or all tenders without assigning any reasons.
- viii) The authority for the acceptance of the tender shall rest with the ICFRE. It shall not be obligatory on the authority to accept the lowest tender or any other tender and no tenderer(s) shall demand any explanation for the cause of




- rejection of his/their tender nor shall ICFRE undertake to assign reasons for declining to consider or reject any particular tender or tenders.
- ix) Conditional tenders are liable to be rejected.

#### 10. PROPOSAL EVALUATION

The bid shall be checked for all qualifying documents submitted by the bidder in the Cover I and disqualification amongst these documents shall lead to the rejection of the bid in toto.

The evaluation committee will determine if the financial proposals are complete and without computational errors. The bidders shall be awarded the contract of only those items for which the certificate of being a Channel Partner / Reseller / Distributor from OEM have been submitted and are found to have quoted the lowest price.






