Quotations received after stipulated date/time shall not be entertained. Rates must be quoted as lump-sum. Quotations in respect of E- Waste shall be entertained only in respect of those firms/ companies who are authorized for this purpose by the respective Govt. authority. The interested parties may contact for inspection of the items on any working day between 10 am and 3pm.

The quotations will be opened by the Committee in the presence of the bidders on 14th October 2016 itself at 4.00 p.m. The bidder will be selected on the basis of the highest bid. The successful bidder will be required to deposit the full amount in cash or submit **a demand draft** in favour of **Director, Rain Forest Research Institute, Jorhat** within 2 working days. The materials must be taken out immediately within 3 days from dated of deposit of money.

Director, RFRI reserves the right of rejecting any or all quotations without assigning any reason thereof at any time. The Bid security will be returned to the unsuccessful bidders immediately after the finalization of proceedings. In the event of any successful bidder failing to submit the entire bid amount or in lifting the materials /items within the stipulated period Bid Security of Rs. 10,000/- will be forfeited.
