TERMS AND CONDITIONS

- 1. Intending tenderers may inspect the vehicles and get satisfied before quoting the rate(s). For this, the parties may contact Coordinator (Facilities) of RFRI, Jorhat during all office days from 9.30 am to 3.30 pm except Saturdays, Sundays and holidays.
- 2. The vehicles will be sold in present condition on "as is where is" basis.
- 3. The intending tenderers will be required to submit Bid Security of Rs. 15,000/- (Rupees Fifteen Thousand only) <u>per vehicle</u> in the form of Demand Draft in original, drawn in favour of Director, RFRI payable at any commercial Bank at Jorhat.
- 4. Sealed tenders super scribing "Tender for Govt. vehicles Tender No......" should reach the "OFFICE OF THE DIRECTOR, RFRI, POST BOX NO. 136, P.O.-JORHAT 785001, ASSAM" OR dropped in the tender box by 05-10-2016 within 3:00 pm.
- 5. Tender box will be opened at 3.30 pm on 05-10-2016.
- 6. The Bid Security in respect of unsuccessful tenderer will be refunded within a week <u>in the case of successful tenderers</u>, the same will be adjusted towards their tendered amount.
- 7. The highest tenderer is required to deposit 25 % of the tender amount on the same day in cash or in the form of Demand Draft from any commercial bank.
- 8. The acceptance of offer of the tender will be communicated within 30 days from the date of opening of the tender.
- 9. The tenderers whose tender is accepted shall have to deposit the full amount with all taxes as applicable after adjusting EMD and 25 % tender amount through Demand Draft within 7 days from the date of the communication of the acceptance of offer.
- 10. On realization of the full payment, the Coordinator (Facilities) will issue delivery order to the successful tender(s) who shall have to remove the vehicle(s) within 30 (Thirty) days from the date of issue of the delivery order.
- 11. The institute shall have no responsibility for the safe custody of the vehicle(s) after 30 days from the date of issue of delivery order.
- 12. If the vehicles are not removed within the stipulated time a penalty will be charged @ Rs. 50/(Rupees fifty only) per day till the vehicle is lifted / removed.
- 13. If the successful tenderer(s) fail to deposit the entire value within the stipulated period, the DIRECTOR, RFRI reserves the right to forfeit the Bid Security and 25 % of the bid amount deposited. The vehicle(s) shall thereafter be disposed of in the manner as the institute deems fit.
- 14. The DIRECTOR, RFRI reserves the right to accept or reject any or the all tenders without assigning any reason thereof. He also reserves the right to relax any/ all of these terms and conditions in the interest of the Government.
- 15. In case of any dispute, the decision of DIRECTOR, RFRI will be final and binding.
