Sealed tenders are invited from the interested buyers **for disposal of various condemned, old and used, vehicular tyres, condemned spare parts and research equipment** as per annexure-1 and 2, lying inside the institute campus of RFRI, Jorhat through **tender cum auction** on **as is where basis** is. Tender form containing the terms and conditions etc. can be obtained from the Store Officer, RFRI during any working day from 10am to 3pm and can also be down loaded from the website: www.icfre.org under option tender.

The **cost of Tender cum Auction document is Rs. 250/-**(non refundable). The parties **downloading** the tender document are required to submit **separately a pay order/demand draft of Rs. 250/- , in original**, as Account payee, drawn in favour of DIRECTOR, RFRI along with the tender document from any commercial bank towards the cost of the document.

The **Tender Document along with EMD/bid security of Rs. 5,000/- for items at annexure 1 and Rs 15000/- for items at annexure 2**, drawn as Account payee demand Draft in favour of DIRECTOR, RFRI, payable at any commercial bank at Jorhat, should reach the "OFFICE OF THE DIRECTOR, RFRI, POST BOX-136, P.O.-JORHAT, 785001, ASSAM" by post OR may drop the Tender in the tender box available in the Store Section, RFRI up to **3.00 pm by 11/12/2014**.

An auction will be conducted in the premises of RFRI **at 11.00 am on 15/12/2014** followed by opening of the tender. Those who are participating in the auction should directly deposit Rs. 5,000/- and Rs. 15,000/- as Earnest Money deposit/Bid security in the form of Cash or Account Payee Demand Draft in favour of DIRECTOR, RFRI, payable at any commercial bank at Jorhat, with the cashier and produce cash receipt to the **Auction Conducting Committee, (ACC)** before commencement of auction.

The tender document should be filled up properly without any over writing /striking and duly signed by authorized signatory is to be submitted in envelop super scribing "**Auction cum Tender for disposal of various condemned, old and used, vehicular tyres and research equipment:14-15** " Tenders with defects and delay shall be rejected summarily.

PRICE BID should be filled up as given in annexure 1 & 2 in the original tender document. Separate price bid paper will not be accepted. **Drop the original tender document in the tender box.**

1. TERMS AND CONDITIONS

- 1) The terms and conditions provided hereinafter form part of the tender cum auction document no:- "Auction cum Tender for disposal of various condemned, old and used, vehicular tyres and research equipment: 14-15 " regarding disposal of Government items as per Annexure-1 & 2.
- 2) Intending tenderers/bidders may inspect the items and get satisfied before quoting/offering the rate(s). For this, the parties may contact **vehicles cell and store section** of RFRI, Jorhat during all office days from 9.30am to 3.30pm.
- 3) The items will be sold in present conditions on '**as is where is**' basis.
- 4) The intending tendersers will be required to submit EMD/ Bid security of Rs 5000/- (Rupees Five thousand only) & Rs. 15, 000/- (Rupees Fifteen thousand only) in the form of cash or Demand Draft **in original**, drawn in favour of Director, RFRI payable at any commercial Bank at Jorhat.
- 5) Sealed tenders super scribing "**Auction cum Tender for disposal of various condemned, old and used, vehicular tyres and research equipment: 14-15**" should reach the "OFFICE OF THE DIRECTOR, RFRI, POST BOX NO-136, P.O.-JORHAT, 785001, ASSAM" OR dropped in the tender box by 11/12/14 within 3.00 pm.
- 6) Record of the sealed tender documents received will be maintained by the authorized officials. Tender box will be opened by the ACC on 15/12/14 for verification of sealed tenders received with the record maintained in this regard. **The sealed tenders will be opened only after auctioning is complete by the ACC in presence of all.**
- 7) Only the Tenderers whose tendered document have been received or Bidders who have deposited Bid security will be allowed to enter the auction premises. A maximum of two persons per party. **No mobile calls will be allowed by any attending party while auction will be conducted.**
- 8) **An auction** will be conducted at 11am on 15/12/14 **followed by** opening of the tenders in the presence of tenderers or their authorized representatives. Competitive bids will be arrived at by putting both the tendered amount and the bids together. The highest tenderer(s) or the highest Bidder(s) named as APPLICABLE will be recommended to the DIRECTOR, RFRI for confirmation of sale.
- 9) **In case, the responsive tendered rate and the bidding amount is found to be same, the tendered amount will be accepted as highest price offered and the tenderer will be named as APPLICABLE.**
- 10) The EMD/ bid security in respect of unsuccessful tenderers/bidders will be refunded within a month. **In the case of successful tenderers/bidders, the same will be adjusted towards their tendered/bid amount.**
- 11) The highest bidder(s) in the **auction or tender** is required to deposit 25% of the bid amount on the same day with the cashier in cash or in the form of Demand Draft from any commercial bank.
- 12) The acceptance of offer/rate of the tender/bid will be communicated within 15days from the date of conducting auction/opening of the tender.
- 13) The tenderers/bidders whose tender/bid is accepted shall have to deposit the full amount with all taxes as applicable after adjusting EMD and 25% Bid amount with the offered value through Demand Draft within 7days from the date of receipt of the confirmed order.

- 14) On the realization of the full payment, the Store Officer will issue delivery order to the successful tenderer(s)/bidder(s) who shall have to remove the items within 30(Thirty) days from the date of issue of the delivery order.
- 15) The institute shall have no responsibility for the safe custody of the items after 30days from the date of issue of delivery order. It will thereafter remain in the institute premises at the risk of successful tenderer(s)/bidder(s) who will bear the penal charge for non removable of the items.
- 16) Request for extension of time for lifting of items shall have to be made to the DIRECTOR, RFRI whose decision will be binding on the parties. If the items are not removed within the stipulated time as mentioned under Clause-14, a penal rent will be charged @ Rs.50/- (Rupees fifty only) per day till the items are lifted/removed. No relaxation in payment of the rental charges will be considered.
- 17) If the successful tenderer(s)/bidder(s) fail to deposit the entire value within the stipulated period, **as per clause 10 & 12,** the DIRECTOR, RFRI reserves the right to forfeit the EMD/Bid security. The items shall thereafter be disposed of in the manner as the institute deem fit.
- 18) No claim whatsoever on this account will be entertained by the DIRECTOR, RFRI.
- 19) The DIRECTOR, RFRI reserves the right to accept or reject any or the all tenders without assigning any reason thereof. He also reserves the right to relax any/all of these terms and conditions in the interest of the Government.
- 20) In case of any dispute, the decision of DIRECTOR, RFRI will be final and binding to all.
