2. The candidates will also be required to stay in tents in forests. If female candidates are interested to apply for the said job under the project, an undertaking on the affidavit to this effect may be required from them at the time of interview.
3. A panel will also be drawn amongst the eligible candidates for a period of one year and subsequent filling up these temporary positions if any, will be done from this panel only.
