Applications received without signature of the applicant or which are not accompanied by the prescribed fee shall be summarily rejected.
- 2. The Council will in no case be responsible for non-receipt of applications or any delay in receipt thereof on any account whatsoever. No application received after the prescribed last date will be entertained under any circumstances and all the late applications will be summarily rejected.
- 3. The application should be routed through proper channel. Photocopies of ACRs grading of the officer for the last five years while forwarding the applications of the candidates should also be attached. However, an advance copy can be submitted along with Demand Draft.
- 4. The deputation period would initially be for a period of three years or till superannuation whichever is earlier as per rules.
