Dr. Sanjay Singh, Scientist 'F' & Head FRCER, Prayagraj spoke on various avenues for collaboration between two institutions in research and extension along with brief overview of FRCER activities in the

recent past. In the opening session mandate and priority areas of both institutions was explained by the respective representatives following which the meet was open for open discussion on following topics:

- 1. About mutual use of expertise and infrastructure of both the institutions.
- 2. Generation of external funds for 'Collaborative Research Programmes.'
- 3. Preparation of collaborative projects on Environmental Impact Assessment and Environmental Audit.
- 4. Time to time organization of public awareness drive on Conservation and Rehabilitation of Ecosystem
- 5. Organization of workshops and educational programs for students and researchers.
- **6.** Importance of Phyto remediation and identification & documentation of potential plant species with the same respect.
- 7. Identification and documentation of wild edible wild plants and medicinal plants of UP, MP & Chhattisgach
- 8. Assessment of status of economically important wild plant species as per IUCN guidelines.
- 9. BSI will help ICFRE FRCER in preparation of mobile app on medicinal trees of UP.
- 10. Adoption of municipal parks of Allahabad for plantation of RET and Medicinal plants.
- 11. Strategies and work plan for public awareness drive which will be organized during Kumbh, 2025.
- 12. Appointment of a nodal officer from both offices for better coordination.
