## Participation in the Inauguration of Ayush Van Establishment at Amarkantak

Madhya Pradesh State Forest Department initiated its establishment of first *Ayush Van* at Amarkantak, the origin of river Narmada on 09<sup>th</sup> October 2021. The first sapling under the programme was planted by Hon'ble Minister of State (MOS) Shri. Ashwini Kumar Choubey, MOEF&CC. *Ayush Van* would be a scheme similar to the *Nagar Van* which would be developed near medicinally-rich ecosystems across the country.

A team of Scientists from TFRI, Jabalpur attended and participated in the medicinal-plant plantation programme at Amarkantak. Various important medicinal plant species such as *Elaeocarpus sphaericus* (Rudraksh), *Chlorophytum arundinaceum*(Safed musli), *Cordia macleodii* (Dahiman), *Curcuma aromatic* (Jangali haldi), *Dioscorea bulbifera*(Gethi kand), *Ficus racemose* (Gular) and *Radermachera xylocarpa* (Garud) etc. were planted under the programme.
