
NOTIFICATION

Subject: Empanelment of CGHS approved / empanelled Private Health Care Organizations (HCOs) at New Delhi with Indian Council of Forestry Research & Education (ICFRE) for providing medical treatment facilities and diagnostic procedures to the ICFRE beneficiaries.

In accordance with the provision contained in para 3(h) of Memorandum of Association (MOA) signed between CGHS and HCOs and in terms of recognition granted to the ICFRE by the Ministry of Health & Family Welfare conveyed vide Ministry of Environment, Forest and Climate Change letter No.2-48/2011-FE, dated 01.04.2015, the undersigned is directed to convey the approval of the Competent Authority in ICFRE for empanelment of Max Super Speciality Hospital, Saket, New Delhi with Indian Council of Forestry Research & Education (ICFRE) from 27.02.2020 for providing medical treatment facilities / diagnostic procedures to the pensioners and serving employees of ICFRE, Dehra Dun and Institutes under it on the terms and conditions specified below :-

1. On CGHS Services:- Cardiology and Orthopedics IPD/OPD both at Max Smart Super Speciality Hospital, Mandir Marg, Press Enclave Road, Saket, New Delhi.
2. Other than CGHS Services:- All services on 2019 Hospital tariff with 10% discount IPD/OPD both on cash basis at Max Smart Super Speciality Hospital, & Max Smart Super Speciality Hospital, 1 & 2, Press Enclave Saket, New Delhi.
3. (Except procedures, Diagnostics & Physiotherapy medicines, consumables, stents, implants & fixed packages etc.)

The Above medical facilities shall be available to the beneficiaries of ICFRE (i.e. serving employees/pensioners on cash basis only. However, the reimbursement of expenditure incurred by the beneficiaries shall be restricted to the rates prescribed under CGHS. The empanelment of hospital will exist till said hospital is empanelled with CGHS of Government of India.
