He has appreciated the efforts put in by the Scientists during these two days deliberations. He further informed that there are different kinds of polices for Bamboos in different states. In some states, it is considered as NTFP whereas in some states is being considered in other forms and advocated that there should be a similar policy throughout the country. In his address, the Director General shared that it is very difficult to get the seeds of Bamboos as it is a long process. He has therefore, stressed the need of ex-situ and in-situ conservation of this species and also advocated the need of raising quality planting material through the above mechanisms.
