In his welcome address, **Dr. VRR Singh,** Director, Himalayan Forest Research Institute, Shimla welcomed the participants and during his speech informed that

Climate Change and Its Mitigation Measures is a burning issue and Government of India has launched eight missions under various Ministries as the Nodal Agencies, which is working under the direct supervision of the Prime Minister's Office. As an impact of Climate Change, the patterns of agriculture & horticulture crops are also getting adversely affected in the state of Himachal Pradesh. To substantiate his views the example he quoted an example during the year 1980s, the Rajgarh area of Sirmour district which used to be a



good belt of apple crops and where early variety apple started to come up in the month of July whereas now apple trees though are there yet no setting of the apple fruit is being seen and climate change is known to be one of major causes for depletion of the same in the lower belts of Himachal Pradesh.

**Shri Saibal Das Gupta,** Deputy Director General, *Indian Council of Forestry Research & Education*, Dehra Dun speaking on the occasion informed that the

Council is a premier organization for taking up forestry research related activities in the country and is operating through its regional Institute and HFRI, Shimla is one of them. The Council is executing a prestigious project on the "Policy and Institutional Reforms for Managing and Up-Scaling of the Sustainable Land and Ecosystem Management (SLEM)", which is being funded by Global Environment Facility (GEF) and ICFRE is one of the Technical Facilitation Organization. He informed that the Essence of this project is to



apply a multi-sectoral approach to land management related biodiversity issues, conservation and climate change/ adaption issues is several states in India. The key objective of this project is to harmonize, coordinate and monitor interventions in agricultural practices and natural resource management that enhance agricultural productivity and at the same time also assessing the ever increasing environmental impacts. He added that this workshop-cum-training programme is being organized as a part of this prestigious project for the benefit of the state of Himachal Pradesh.
