## OFFICE MEMORANDUM

Subject:-

Revision of Rates of Contribution under ICFRE Pensioners, Health Scheme w.e.f. 01.01017 regarding

In accordance with the provision laid down under sub clause 3.2 of Chapter-2 of the Rules of the ICFREPHS, the amount of contribution towards the membership of ICFREPHS indicated in clause 3 of said Rules shall be revised from time to time as per the applicable rates of contribution approved by the Ministry of Health in its Medical Health Schemes. Since the Govt. of India, Ministry of Health & Family Welfare have revised the rates of contribution to be made by the Pensioners for availing benefits under the CGHS with effect from 01st January, 2017, accordingly rates of contribution revised by the Govt. of India, Ministry of Health and Family Welfare under CGHS shall be applicable in ICFRE for availing benefits under ICFREPHS. As such the Pensioner/family Pensioners who will opt to become a member of ICFREPHS or to extend his ICFREPHS membership beyond the present validity period shall have to contribute the amount detailed below w.e.f. 01.01.2017 in accordance with the corresponding Grade pay drawn at the time of retirement /death:-

The ICFRE Pensioners who have already obtained ICFREPHS membership with Lifetime validity prior 01-01-2017, will not be required to pay any additional amount as a result of revision of rates of contribution for availing ICFREPHS facility. Entitlement of such Pensioners/family pensioners will not be changed.

The Clause 3- ICFREPHS Pensioners' Health Scheme Contribution of Chapter 2 of Rules of ICFREPHS stands modified to the extent indicated above w.e.f. 01st January 2017.
