Its mission is to generate, develop and disseminate knowledge, technologies and solutions for addressing issues relating to forests and promote linkages arising out of interactions between people, forests and environment on a sustained basis through research, education and extension.

The Environmental Management Division of ICFRE is engaged in carrying out consultancy projects related to the Environmental Management for various development projects in the country and abroad. The major areas under consultancy projects includes the environmental impact assessment studies for hydropower and mining projects, preparation of environmental management plan for hydropower and mining projects, cumulative environmental impact assessment studies for hydropower projects based on river basin, biodiversity assessment studies for developmental projects, post project monitoring and evaluation studies of afforestation /plantation, monitoring and evaluation of catchment area treatment plan, preparation of reclamation and rehabilitation plan for mining projects of iron ore mine, conduct of environmental audits of open cast coal mines, environmental compliance rating and environmental performance indexing of complied conditions of open cast coal mines and carrying capacity studies of forest areas for resource assessment for sustainable utilization.
